MASON PUBLIC SCHOOLS:

MASON PUBLIC SCHOOLS OPERATING MILLAGE PROPOSAL WILL ALLOW THE SCHOOL DISTRICT TO CONTINUE TO LEVY THE STATUTORY RATE OF NOT TO EXCEED 18 MILLS ON ALL PROPERTY, EXCEPT PRINCIPAL RESIDENCE AND OTHER PROPERTY EXEMPTED BY LAW, REQUIRED FOR THE SCHOOL DISTRICT TO RECEIVE ITS FULL REVENUE PER PUPIL FOUNDATION ALLOWANCE AND RESTORES MILLAGE LOST AS A RESULT OF THE REDUCTION REQUIRED BY MICHIGAN CONSTITUTION OF 1963.
