

Building Permits

Thank you for choosing to invest in Mason. Building permits from the City of Mason are required for:

- Roofing and siding,
- New construction, additions, remodeling, window replacements involving structural modifications, demolition, moving of structures, decks, sheds, garages and carports,
- Any type of swimming pool capable of holding 24 vertical inches of water, including inflatable pools,
- Permanent signs, and
- Fencing over 6 feet in height.

Exceptions to this requirement are as follows:

- One-story detached accessory structures 200 square feet or less,
- Retaining walls not over 4 feet in height measured from the bottom of the footing to the top of the wall, unless supporting a surcharge (earth),
- Painting, tiling, carpeting, cabinets, counter tops and similar finish work,
- Prefabricated swimming pools that are designed to hold **less** than 24 vertical inches of water, and
- Fences 6 feet or less in height. Additional requirements do apply. Please see 'Fences' brochure or call Customer Service at 517-676-9155.

When a building permit is not required, other setbacks or requirements may apply. See City of Mason Code of Ordinances Part II. Chapter 100 – Reference tables and figures*.

Other Permits

Your project may require additional permits in the City of Mason including:

- A soil erosion permit or waiver from the Ingham County Drain Commission is required for all building projects and must be submitted with your Building Permit Application to the City of Mason.
- Certain uses requiring a Special Use Permit or Site Plan Review – See City of Mason Code of Ordinances Part II. Chapter 94 – Zoning*.
- Any construction in the right of way such as driveways, water, sewer, and storm sewer repair; authorization from the Ingham County Road Department or Michigan Department of Transportation may also be required depending on location of work.

Permit Fees

Permit fees are based upon an estimated value of the work being done and the "cost per square foot" guidelines set by the International Code Council's Building Valuation Table. Once the building permit has been approved, you will receive a call from staff. **Permit fees are to be paid at the time you submit your application.** Our current schedule of fees is printed in our Directory of Charges, available at the Customer Service desk or on our website.

*Know Your Zone

Use the **Zoning Map** at the Customer Service desk or online to determine what zoning district your project is in.

Completed applications may be mailed or returned in person to the Customer Service desk at City Hall.

Your project is important to us!

On average, it takes between 2-5 days to get a building permit.

Please help us process your permit as quickly as possible. To avoid delays, review the application carefully and submit all required documents.
